1 HON H. MCGLUWA ASKS THE PREMIER:

1. (a) (i) Does the Premier have any intention of ensuring that the HOD of Health and his coaccused in the PPE criminal case are suspended (ii) what internal disciplinary action, if any, has been taken against the HOD for violating the PFMA and if no action has been taken, why not (b) how does the Premier justify retaining a criminally convicted and sentenced person at the helm of the health department (c) for what period is the current HOD's position valid (d) to what extent do you think that the provincial health department's progress has been hamstrung by corruption?

2 HON I. FRITZ ASKS THE MEMBER OF THE EXECUTIVE COUNCIL FOR HEALTH:

1. (a) (i) What is the monthly payment amount due to Defensor Security (ii) when was the last payment made (b) given previous AG findings of irregular expenditure that relate to the month-on-month contract, what have you done to prevent similar findings (c) (i) how is it possible that a newborn baby was stolen from Robert Mangaliso Sobukwe hospital and (ii) what measures have been taken to improve security and access control at the hospital?

1. (a) Can the MEC clarify the governance and administration of private educational facilities that are located on the same premises as public educational facilities, such as the private crèche sharing its facilities with Hoërskool Hopetown?
